ARTICLES OF INCORPORATION

ALLEGHENY RIVER TRAIL IN CLARION COUNTY, INC.

FIRST: Name: The name of the Corporation is Allegheny River Trail in Clarion County, Inc.

SECOND: Registered Office: The location of the Corporation's registered office is Foxburg, Clarion County, Pennsylvania. Its current mailing address is c/o Robert L. Jennings, Jr., Esq., 132 Anton Landing Drive, P.O. Box 325, Foxburg, PA 16036-0325. The Corporation also receives mail at P.O. Box 9, Foxburg, PA 16036.

THIRD: Purpose: The Corporation is formed exclusively for charitable and educational purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code of 1986, as the same may be amended or modified or replaced by any future United States Internal Revenue Law (the "Code"), including, without limitation, to do the following: the Corporation shall exist solely for such charitable and educational purposes as are deemed appropriate by the Board of Directors to further the public welfare and to benefit mankind, including:

- (a) The land access or rights of way acquisition, design, construction, maintenance, operation, promotion and marketing, of a public use non-motorized trail along or close to the Allegheny River in Clarion County, Pennsylvania, beginning with the uncompleted segment from Emlenton, PA to Foxburg, PA, and then extending several miles of a completed trail, thereafter south from Parker, PA to at least Upper Hillville, PA., if not to the southern border of Clarion County, PA at Red Bank Creek, where it enters the Allegheny River;
- (b) Such comparable land access or rights of way acquisition, design, construction, maintenance, operation, promotion and marketing, as deemed necessary or appropriate, to connect with non-motorized trails to the north of Emlenton, PA, and south of Upper Hillville;
- (c) Such comparable land access or rights of way acquisition, design, construction, maintenance, operation, promotion and marketing, as deemed necessary or appropriate, to connect with or offer, other local recreational opportunities for the public, such as access to boat launches, hiking trails, primitive camping, picnicking etc.;
- (d) Such publicly available amenities associated with any of the foregoing, as are deemed necessary or appropriate, such as fundraising, membership activities, signage, educational, historical or natural science displays or signage; and,
- (e) Participate, as deemed appropriate, in any local, regional, State, national or other efforts to coordinate, regionalize, or otherwise expand public access to, and understanding of, such recreational activities and opportunities.

FOURTH: Existence: The Corporation's existence shall be perpetual.

FIFTH: Non-Stock Basis: The Corporation is organized on a non-stock basis.

SIXTH: Pecuniary Gain or Profit: The Corporation does not contemplate pecuniary gain or profit, incidental or otherwise.

SEVENTH: Earnings: Notwithstanding any other provision of these Articles, no part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its members, directors, trustees, officers or any other private individual; provided, however, the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered to the extent that such payments do not prevent it from qualifying, and continuing to qualify, as an exempt organization and to make such lawful payments and

distributions in furtherance of the purposes set forth in Article 3 hereof as may from time to time be either required or permitted by Section 501 (c)(3) of the Code.

EIGHTH: Exempt Organizations: Notwithstanding any other provision of these Articles, the Corporation shall not engage directly or indirectly in any activity which would prevent it from qualifying, and continuing to qualify, as a corporation described in Section 501 (c)(3) of the Code (hereinafter referred to in these Articles as an "exempt organization"), or as a corporation contributions to which are deductible under Section 170 (c)(2) of the Code. No substantial part of the activities of the Corporation shall be devoted to carrying on of propaganda, or otherwise attempting to influence legislation (except as otherwise provided in Section 501 (h) of the Code), and the Corporation shall not participate in or intervene in (including the publishing or distributing of statements) any political campaign on behalf of or in opposition to any candidate for public office.

NINTH: Dissolution: In the event that the Corporation shall be dissolved or liquidated, the Board of Directors, after paying or making provision for payment of all of the known liabilities of the Corporation, may transfer or dispose of the Corporation's property and assets to (a) such one or more corporations, trusts, funds or other organizations which at the time are exempt from federal income tax as organizations described in Section 501(c)(3) of the Code, and, in the sole judgment of the Corporation's Board of Directors, have purposes similar to those of the Corporation or (b) the federal government, or to a state or local government for such purposes. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction exclusively to one or more of such corporations, trusts, funds or other organizations as said court shall determine, which at the time are exempt from federal income tax as organizations as described in Section 501 (c)(3) of the Code, and which are organized and operated for such purposes, or to the federal government or to a state or local government for such purposes. No private individual shall share in the distribution of any Corporation assets upon dissolution of the Corporation.
